The information requested below will enable Watch Tower Legal Department (the "Legal Department") to provide legal advice to the congregation and others who share a common interest with the congregation. The information will also enable the Legal Department to jointly defend the congregation elders, and the organisation of Jehovah's Witnesses, should litigation arise. To preserve lawyer-client confidentiality, this form should not be shared with anyone, except the Legal Department. If questions arise, please call the Legal Department at 020 8371 3416.

The body of elders should assign two elders to investigate the allegation(s) and complete this questionnaire after reviewing the following instructions.

- Please fill in this questionnaire as completely as possible, doing so as a matter of priority. We appreciate how busy you are and how challenging this may be, and we are grateful for your kind assistance. Given the great importance of child safeguarding, we know you will follow through diligently and Jehovah will surely be with you as you do so. (Prov. 18:13; Jas. 1:5)
- The information requested below focuses on the alleged sexual abuse or sexual misconduct involving the specific accused (B1) and the specific victim (C1). A separate questionnaire should be completed for each alleged victim. If you become aware of other victims or other crimes relating to this specific accused, call the Legal Department right away to receive further legal advice. (See letters to all bodies of elders dated October 1, 2012, and November 6, 2014.)
- As part of your investigation, speak with the accused and any adult victim when possible. **Do not speak with a minor without first telephoning the Legal Department.** As needed, you may orally consult with the body of elders of any congregation that has knowledge of the matter. If you have any questions regarding whether to contact a particular person or body of elders, please contact the Service Department.
- Read all of the questions carefully and provide *concise* answers. Answer all questions. Do not guess. If an answer is unknown, type "Unknown." If a question does not apply, type "N/A."
- When identifying individuals, use proper names and include other names they are also known as. Try to limit the use of pronouns (e.g., he, she, him, and her) in your answers.
- When providing dates, spell out the name of the month (e.g., September 1, 2015). When providing a congregation name, include the city.
- Confirm that the ages specified in Section E agree with the dates of birth for the accused and the victim specified in Sections B and C.
- **Slowly** placing the pointer or cursor over an answer field will provide you with additional instructions and examples.

The body of elders should review this questionnaire before returning it to ensure accuracy and compliance with these instructions. Within **two weeks**, the elder who received the questionnaire should reply electronically to the original message in his jw.org inbox and send the Legal Department the completed questionnaire as an attachment. **Do not send the completed questionnaire using any other method. Do not send any attachments along with this questionnaire.**

General legal advice and direction:

- 1. The body of elders should review the applicable portions of the following direction: The Shepherding extbook (ks10: chapter 12, paragraphs 18–21 (reporting child abuse allegations and no legal suggestions to others); chapter 6, paragraphs 18, 19 (when media and/or authorities contact elders); chapter 4, paragraph 21 (treating victims with thoughtfulness and kindness); chapter 5, paragraph 39 (interviewing minors). Letters to all bodies of elders: November 17, 2010 (letters of introduction); November 6, 2014, paragraphs 10–12 (confidential information and court summons), and paragraphs 17–19 (restraining orders and disruptive individuals); April 10, 2012 (child pornography); and October 1, 2012 (child abuse). Please also review the Child Safeguarding Policypar. 13 (inform parent); par. 14 (child at risk). If you have any questions about how to apply this information or if you need other theocratic direction, please telephone the Service Department.
- 2. If this becomes a congregation judicial matter, it should be handled just as any other case of serious wrongdoing, with the exception that the circuit overseer should be contacted for him to appoint a chairman (letter October 1, 2012, par. 11). The body of elders should monitor the situation carefully for the protection of other potential victims. Telephone the Legal Department again if any elder hears of the alleged/confessed abuse from any other person, learns of a new victim, or learns other new and significant information. Also, telephone the Legal Department again before interviewing any minor.
- 3. If any congregation elder learns of a case of child abuse in which a child may still be at risk of significant harm (as defined by law and decided cases) the congregation elder together with the congregation coordinator of the body of elders, or in his absence another congregation elder, are required to contact a Safeguarding Elder at the branch office of Jehovah's Witnesses to request situation–specific guidance and direction. A report to the police or other appropriate authorities will be made immediately by the congregation elders if it is determined that a child is still at risk.
- 4. Do not send the Legal Department or the Service Department any electronic or written correspondence <u>unless you are specifically requested to do so</u>. So as to protect the confidentiality of the legal advice you receive from the Legal Department and victims' privacy, please do not create any notes during any future investigation or judicial action.

We trust this direction will help you in caring for such delicate matters.
