The silence must be broken so that they can be protected and helped to escape their clutches.

There is an actual ring of pedophiles in this organization who are grooming children for sex. And people need to know about it. Satanism is involved. They use Watchtower doctrine and policy along with threats to terrorize their helpless little victims into silence.

The Society has tried to play down the existence of satanists in this organization, however, there are too many victims to effectively squelch it. As an adult I have met quite a few who also recall having been abused by Jehovah's Witnesses who were also practicing satanism. Some of these ARE elders in various positions in the organization.

Recently, I was driving to an appointment with an attorney and as I was praying and asking Jehovah what I should say to him, I was shocked when it came to my mind that if the Society applied the same "two witnesses" rule, which they use for determining if a child was truly molested and a perp is guilty, to their investigations into the accusations of satanism and Satanic Ritual Abuse with a network of satanists in this organization which stretches across the country, then it is no wonder that they came up with "nothing."

I was shocked and horrified to read of the Society's view towards child molestation. I was raised a Jehovah's Witness, but left the congregation when I was fifteen. Although my story differs somewhat, it is yet another example of how the congregation's elders have abused their power. My sister was raped when she was twenty-four by a man she did not know. The man had come along with my sister's best-friend and her husband to try to find employment in our city. My sister was not comfortable with this man staying at her apartment as he was worldly and she did not know him. She let him stay to watch a movie and then he was going to go stay at a hotel. She felt safe doing this because she was not going to be left alone with him as her best-friend and husband would be there. She also did not want to convey an unfriendly attitude towards him. He had shown some interest in the truth and she did not want to portray the congregation as unsympathetic to a potential study who had traveled quite a distance. Unfortunately, her best-friend and husband decided to go to bed before the movie ended, but my sister didn't think much of it because the movie was almost done. After he was sure everyone in the apartment had gone to sleep he decided to make his move. My

sister spurned his advances emphatically and told him to leave. That's when he decided he was going to have her whether she liked it or not. In other words, he raped her. After it happened, my sister told my father who told her that she must tell the elders about what happened. He thought that they may be able to provide her with spiritual counseling to help her through the aftermath instead of her seeking outside worldly professional help. To make a long story short, they disfellowshipped her. Their reason was that she was guilty of "loose conduct that lead to fornication." They said she should have never had him in her home in first place and then this wouldn't have happened. They also said that because she only told him "NO!" repeatedly and did not scream that she was not emphatic enough and he must have thought she was enjoying it. I lost all faith and respect for the truth the day she was disfellowshipped. I will never step foot in another kingdom hall.

I think what you are doing with this website is very courageous of you. I WAS FORCED TO HAVE A HYSTERECTOMY AT AGE 32. I WILL NEVER BE A MOTHER. I WILL NEVER HAVE CHILDREN. I WILL NEVER BE A GRANDMOTHER. I WILL NEVER GET OVER THIS. THERE ISN'T A DAY THAT GOES BY THAT I DON'T GRIEVE MY LOSS. I BLAME THE WTS AND JW'S FOR MY LOSSES. A day late and a dollar short, I began to realize that even though I was severely depressed I would just force myself to go to the "meetings" and instead of feeling better I felt WORSE. The feelings were so unbearable and unpleasant I stopped going altogether. I had a sense of relief as I slowly began to drift away, beginning in 1988. I was without God for 2 years from 88 to 90 and then by numerous coincidences I was drawn back to the Catholic church. I carefully and cautiously returned and to my delight it was NOT the church I left in the 70's due to the Vatican II council implementing all the changes- otherwise I would have never returned. On April 10, 1993, I was fully received into the Church. I felt FREE and finally at spiritual peace. However, in 94, by accident I discovered that JW's were a cult and when I learned that I had been in a cult and brainwashed, etc. I was devastated and went into a tailspin, as I realized it had all REALLY been for nothing and that my wasted youth could have been prevented, etc. I blamed myself. I blamed God (why does he allow these hideous religions in His name? Why didn't he protect me?). I quickly got into therapy and was able to come to terms with my JW past and was able to move on. I did not have a computer, so when I learned of the cult/brainwashing I contacted every ex JW exit expert (Randy Watters, David Reed, etc) and bought over 15 books. I did have major healing. I didn't get a computer until June of 2000 and I now find wonderful support from ex JW's everywhere. I am at spiritual peace now and as far as I'm concerned, that was another lifetime. However, I am learning so many ugly, ugly things about the entire organization AND IT MAKES MY BLOOD BOIL. These sons of bitches, these bastards, these f-----g are getting away with "murder. " I AM SO ANGRY ABOUT THIS. I don't know what to do with my anger towards the ORG and JW's. I am feeling such strong, negative emotions I am not used to feeling. I AM SORRY BUT I HATE, HATE, HATE, HATE, HATE, HATE, THE WATCHTOWER SOCIETY, THE ORG, AND JEHOVAH'S WITNESSES. I wish they could be removed from the planet, that is how anary I am and how much I detest them. I can't believe they are getting away with RAPING CHILDREN. This must stop and it must stop NOW!!! What do we do? How do we make the public stand up and DO SOMETHING. Of note, as a Catholic, I also do not appreciate how my church has handled such perverted filth, either. My heart just ACHES for anyone who is part of this website because some perverted adult used power and control over you, threatened you with harm if you told what happened and even had the gall to say the fake "god" jehovah (who DOES NOT EVEN EXIST BY THE WAY) would punish you or kill you at the so called Armageddon (also fake). Hello, Bill. I agree with all of the many fine comments from those who have posted here. May our heavenly Father and His Son, bless you and your family and those who are helping to support your efforts in providing help and support such as this for the "silent lambs".

I had a JW uncle who had been molesting one of his own daughters for years, until the daughter exposed him to the elders after she became became married and an adult. His activities were kept covered and in each congregation he moved into, he was able to molest children of JW because no one warned that a pedophile had moved into their congregation. This man even molested the child of the daughter he had been molesting for years. She had left her daughter with her mother (my aunt) and gave instructions that she was not to let that baby out of her site! I don't know the full details, but for some reason, the baby's grandfather was able to get to her too. This man had been disfellowshipped a number of times, but would be re-instated because he claimed that he was repentant. Now he is in a nursing home, and fortunately he is no longer able to get a hold of any more children.

My own grandchildren (boy and girl aged 3-4) were both molested by a teenage JW boy my ex daughter-in-law allowed to baby sit for her. She would leave those kids with him both all day and all night. When she found out about his abuse, she did not hesitate to turn him in to the police, because she was so angry at him. (And angry at her self for trusting him too much. The children's father,(my son)tried to warn her about the danger but she would not listen until it was too late. (at that time she and my son were divorced, and he had allowed her full custody) At that time the

teenager's own JW parents couldn't keep him under control themselves. Just this alone should have at least given her a hint.

In the same congregation before this happened, a JW sister also let a JW older teenage boy baby sit her young boy occasionally. (this was a different teenager who was a son of one of their auxiliary pioneers and long time congregation member. He had seemed to be a very nice trustworthy boy to everyone who knew him. As it turned out, he had been molesting their young boy and the boy's parents were not aware of it until the child began to tell them things. The teenager was not turned in, and the elders began to give the teenager allot of special attention, but not much personal attention was given to the molested boy. The boy's mother became upset about this. The elders appeared to be giving him allot more personal,friendly attention at the meetings than they did before. (and were even conducting a personal home Bible study with him) (While no such offer of a study was extended to their son. Or at least no special attention set aside for him) This really crushed the boy's parents. (it made them sick to see how those two elders were overly friendly now to the molester at the meetings while their son didn't get that kind of attention. I believe that the elders meant well, but they just didn't know how to properly handle the situation. Especially with no particular training.

The experience caused the mother to go to the internet to see what others had to say concerning the Watchtower Society and their policies. Consequently, she apparently must have came across many of the older WTS literature quotes that exposed precisely what the WTS was preaching and teaching during the years they claim that Jesus had returned and inspected the temple. She must have discovered that if he had inspected the temple during the years of 1914-1919 he would have found that they had "pushed ahead, and had not waited on him, because they were teaching and preaching:

1)Jesus had already returned. (1874) 2)The first resurrection had already began. (in 1878) 3)The heavenly door already closed. (in 1881) 4)A new date for Armageddon. (1925)

They also were using the cross and celebrating all the Holidays the WTS frown on today. (besides, voting in their elders)

These events that happened with this mother and her molested boy,was while I had not yet learned the truth about the WTS myself. I had been born and raised in it along with my sister and my brother. (our parents had spent most of their lives waiting to survive Armageddon which kept delaying until they both died of old age health problems. The rumor going around the Kingdom Hall at that time was that this mother (of the abused boy) had learned something about the Organization which caused her to be even more upset and finally she herself was confronted before a judicial committee and was disfellowshipped. I had heard that she no longer believed that the "Faithful and Discreet Slave" were being used by Jehovah as His "channel" to give "food at the proper time". It left many of us puzzled. She and her husband ceased coming to the meetings, and soon moved away. I wish that I had learned then,what I know now,for I would have made sure I kept in contact with her. I am still trying to locate her. I now can see that if Jesus had returned during those years of 1914-1919, he would have discovered that the WTS had presumptuously"pushed ahead" by preaching that he had already returned in 1874,etc. He would never have commended them by saying "well done, faithful and discreet slave. For they weren't faithful nor were they discreet. They stumbled many people with those false dates and prophecies.

Jesus himself even warned us by saying: "For false Christ's and false prophets will arise and will give great signs and wonders, so as to mislead, if possible even the chosen ones. Look! I have forewarned you. (Matt. 24:24-25) (see Deut. 18:20-22)

I now believe that Jesus has not even returned yet. For many years we had been preaching something that wasn't true. (C. T. Russell and Judge Rutherford was obviously wrong the first time with their date of 1874 which they accepted from the Adventists, and they have no convincing proof they even have it correct today.)

My son and I learned what she found out around the late 90's. Before I finally left the WTS I partook at one of the Kingdom Halls which was nearby. Not once had I ever missed a memorial at a Kingdom Hall. I reasoned that before I left, I was going to finally celebrate it in the correct way. The way that I should have been celebrating it and my parents should have, and the way that Jesus himself expects us to.

Funny how many times we sang that Lord's Evening Meal song and sang the words. . . "Before us there spreads a fine table of wine and of unleavened bread. They are symbols we know, as reminders they show, with what nourishment WE MUST BE FED. " Yet most of us just let it go right past us in spite of Jesus'words at John 6:51,53:

"This is the bread that comes down from heaven, so that ANYONE may eat of it and not die. Most truly I say to you, unless you eat the flesh of the Son of man and drink his Blood you have NO LIFE IN YOURSELVES."

" You are all, in fact, sons of God through \*your faith in Christ Jesus. For all of you who were baptized into Christ have put on Christ. " [Galatians 3:26-27]

However as many as did receive him, to them he gave authority to become God's children \*because they were exercising faith in his name\* and they were born not from blood, or from a fleshly will, but from God. " [John 1:12-13 ][[Romans 9:33 1 Peter 2:6. . Romans 5:1-5]

" knowing as we do that a man is declared righteous not due to works of law, but only through faith toward Jesus Christ. " [Halation 2:16]

Just as Ephesians 4:4 says there is "one hope" and Romans 8:24 says "We were saved in this hope". There is no evidence to show that Jesus or anyone else has returned and changed the hope. It is the same. And we should be preaching the original Christian gospel and stop teaching a changed hope. Galatians 1:8 warns: ". . if we or an angel out of heaven were to declare to you as good news something BEYOND what we declared to you as good news, let him be accursed. "

"We have no doubt whatever in regard to the chronology relating to the dates of 1874 . . " [WT May 15 1922 150]

"Surely there is not the slightest room for doubt in the mind of a truly consecrated child of God that the Lord Jesus is present and has been since 1874..." [Wt, January 1, 1924, p. 5]

"The Scriptural proof is that the second presence of the Lord Jesus Christ began in 1874 A. D. " [Prophecy, 1929, p. 65]

"The time of the Lord's second presence dates from 1874, as above stated. " [The Harp of God p. 236, 1928 edition]

"That the harvest began in 1878, there is ample and convincing proof. The end of the harvest is due in the spring of 1918. " [The Wt, May 1, 1918, p. 6243]

"And it was in 1878, then, that the process of setting up the kingdom began. Then our Lord raised the sleeping saints from the tomb and joined them to himself " [WT June 1 1922 p. 174]

"Bible prophecy shows that the Lord was due to appear for the second time in the year 1874. Fulfilled prophecy shows beyond a doubt that he did appear in 1874. Fulfilled prophecy is otherwise designated the physical facts; and these facts are indisputable. " [WT Nov. 1 1922 p. 333]

"No one can properly understand the work of God as this present time who does not realize that since 1874, the time of the Lord's return in power, there has been a complete change in God's operations. " [Wt, September 15, 1922, p. 278]

"As in the type that date - three and a half years after the death of Christ - marked the end of all special favor to the Jew and the beginning of favor to the Gentiles, so we recognize A. D. 1881 as marking the close of the 'high calling, or invitation to the blessing peculiar to this age - to become joint-heirs with Christ and partakers of the divine nature. " (The Time Is At Hand; 1889; 1915 ed.; p. 235)

"In the year 1943 the Watch Tower Bible and Tract Society published the book "The Truth Shall Make You Free. " In its chapter 11, entitled "The Count of the Time," it did away with the insertion of 100 years into the period of the Judges and went according to the oldest and most authentic reading of Acts 13:20, and accepted the spell-out numbers of the Hebrew Scriptures. This moved forward the end of six thousand years of man's existence into the decade of the 1970's. Naturally this did away with the year 1874 C. E. as the date of return of the Lord Jesus Christ and the beginning of his invisible presence or parousia. " [God's Kingdom of a Thousand Years 1973 p. 209, par. 55] (Frederick Franz)

(My comment: Did you notice this folks? The belief that Jesus returned in 1874 was not officially done away with (changed) until 1942! Yet we were led to believe that the WTS had always expected Jesus' return in 1914.)

Jesus said that by their fruits, you will know his true followers. Based on Laura's and many others' experiences it's clear that Jehovah God is sending us all a message that the religion called Jehovah's Witnesses has \*NOT\* found the truth. Rather than blindly reciting Jesus's words about trees that bear rotten fruit, one should pay attention to these words. Many of you reading this are attending congregations filled with good fruit. Let me give you an illustration about why your observations about your religion should \*NOT\* be limited to your own congregation. The Watchtower Society's claim that Jehovah's Witnesses are "the one true religion" is based on the organization's fruits. The organization consists of almost 100,000 congregations. These congregations are like baskets of fruit. The organization is like a large warehouse. The baskets of fruit cover the floor of this massive warehouse. In order to decide if the inventory of fruit in this warehouse is "good fruit" or "rotten fruit" one must inspect the entire inventory. Walking passed rows of fruit baskets with a pen and clipboard, one can place a tick-mark under the column "Good Fruit" if a basket looks fresh and good as a whole, or "Rotten Fruit" if a basket looks overly ripe as a whole. Then add all the tick-marks in each column, and calculate the percentage of rotten fruit in the warehouse. Generally if the inventory contains rotten fruit greater than 10-20 percent, then it's safe to conclude the entire inventory is in question. Jesus therefore was helping us to realistically evaluate whether the religion we choose contains "good fruit" or "rotten fruit" -- not by simply looking at our own "fruit basket" or congregation, but by getting a sense of the overall condition of \*ALL FRUIT BASKETS\* or all congregations in the religion we are evaluating. Upon finding a religion filled mostly with good fruit, we can safely attend the meetings, gather with others of that religion to worship God, and decide to what extent we will personally engage in witnessing the good news of the kingdom to others. To the chagrin of the Watchtower's governing body and sorrow for those who have spent their life as Jehovah's Witnesses, Silentlambs is busy tallying the extent of one type of fruit contamination in this organization. The result is discovering that the child abuse and pedophile problem alone has infected the fruit so extensively that Jesus would surely label this tree as one bearing rotten fruit. When you mix good fruit with rotten fruit, the good fruit becomes infected (just as a little leaven ferments the whole lump). Those who still are good fruit in their hearts and lives should consider separating themselves from the rotten fruit, to themselves remain untainted. This involves the very major life change that one faced when getting baptized as one of Jehovah's Witnesses, in effect bringing many full circle to where they started. Is your love for Jehovah God intense enough to start your quest for the truth all over again? Are you willing to walk back the way you came to that fork in the road, and examine your compass again to re-decide your course in life? As of recently in the Watchtower magazine information on this very subject (pedophiles in the congregation) has been written, I am sorry that I cannot provide you with an exact date, but it read that under no circumstances will anyone, brother or sister that has been found to have a sickness as horrific as this will ever hold a position as an elder,

ministerial servant, pioneer etc. They are not even allowed to have any privilege whatsoever ie. . carrying microphones or passing our bible literature at the local Kingdom Halls. They are under strict supervision at all times, unable to take young people out in the field ministry or conduct bible studies at anyone's house. And also it is made aware to others in the congregation that there has been a matter within the congregation that directly involves the children. It is in no way hidden or "covered up!" In fact I am personally aware of a so-called brother who is serving 20-35 years in San Quentin for such abuse. He was not protected at all by the Elders or the congregation. If someone is accused of this, it is taken very seriously, Because of this accusation the accused is still watched very carefully being told he may never be in the presence of children or young people alone or cannot frequent homes that have young ones there. True or not the accusation may be, but the elders take this matter very seriously and recommend the accuser to seek counseling and they follow up on the matter quickly and in a loving way.

Hello Dana, I noted your post and appreciate your optimism regarding the handling child molestation within the organization. I was much like you in having complete trust in the Society as to handling these matters properly. I was PO in my congregation until 12-31-00 so I am familiar with current information concerning this issue. As a matter of fact when I as an elder had to deal with an actual case of child molestation in my congregation it was only then did I realize how bad WT policy actually was. I had eight conversations with WT service and legal in an effort to have a fellow brother reported who had molested a ten year old multiple times. I was told to "wait on Jehovah". I decided Jehovah did not want me to wait when a person commits a crime against children.

I understand to that many elders do try to do the right thing in dealing with these matters, but if wt legal gets involved they have to do as instructed. It appears from your comments you have not read much of the website. I encourage you to do so as I think it will help you have a clearer picture of this matter. Read the victims page, are all these people lying about being molested as children? I have personally talked to hundreds who give names, congregations, and places. I believe them, while every detail may not be factual, I believe they were molested and hurt by wt policy. The wt you refer to is 1-97 I am very familiar with the article as I conducted the wt study and after doing so felt very good about the new policy. Three months later we elders got a letter in March that stating otherwise. That is, child molesters could continue to serve if it had been a long time ago. That point was not mentioned in the article. If you review the body of elder letter of 6-1-01 written to British congregations you will see it is still wt policy as of 6-01. You may review these letters on my website under wt letters.

You see, it is about telling the truth, I have no axe to grind with the Society, I simple cannot morally and ethically go along with a policy that hurts children. I wrote this to the Society in December of last year. You may read my letter on the website where I outline the full extent of the problem with wt policy. How did the Society respond? They said, "we accept your resignation". I have been associated for 43 years as a JW, close to 20 years as an elder and not one word of counsel was offered to readjust my thinking. Don't you think an old timer like me would at least disserve that?

So once again I encourage you to read the points mentioned and also you might review the sentencing hearing of Erica and Berry where between them, close to forty JW's pleaded for a judge to let the convicted child molester go and a good portion stated they would like the molesters to baby-sit their children. Do you see anything wrong with this picture?

As a JW we are taught to stand up for what is right no matter what the odds. I stand for what I believe to be right on this issue and I can prove it. If after reviewing the material suggested you would like to discuss this further I will be glad to discuss it with you. The conversation will be confidential of course.

I encourage any and all to write the Society and ask for them to change WT policy on this matter.

Three things should be adjusted:

1. If your child is molested, go to the police first and report the matter. 2. A child molester should never have any position of authority in the congregation. 3. A child molester should never be allowed to go in the door to door ministry.

Currently none of these are WT policy. Does that seem like to much to ask? I know these things are disturbing, but sometimes you have to get disturbed to get to the truth. For you to write I feel you must be sincere. I hope you find the truth of these matters.

This very kind brother said to me and these are his EXACT WORDS (and I hope it doesn't get him in trouble): "I agree with you 100%. " He said that they had received many letters from sisters which were 10-15 pages long and that they were too lengthy to pass around to be read. And, he said that NO ONE had ever said what I told him. NO ONE had ever said that what the "friends" were saying and believing was rendering the victims more VULNERABLE and putting the victims AT RISK!

He proceeded to ask me to write what I had told him, and to be sure to include what I said about being made VULNERABLE and put AT RISK, on a "one page letter, signed on that page" and he gave me the exact address to send it to them. He promised me that he would to see to it that those who needed to read it would get a copy. However, he said he could not promise what would happen after that.

A little over a month later I received 2 form letters from the WT Writing Dept. in response. In the second one, which was identical to the first except for some additions, they 'commended the elders' who had hurt me!!!!! Can you imagine how that felt? I was devastated!!!

I had BEGGED the WT, the Society, our "Mother" as they told us they were, to come to our aid, to stand up for us, to cover us and protectively shield us, to be the parents we never had. Instead, they commended the elders who hurt me! This is just a piece of what transpired.

I just a few minutes ago got off the phone with the United Nations. The Watchtower Bible and Tract Society has been an affiliate in the NGO/DPI section for 10 years. (See www. un. org) They are registered under the subject of HUMAN RIGHTS. I let the UN know that my Human Rights were violated again and again by this organization which is affiliated with them and is supposed to be supporting the work of the UN in the area of Human Rights.

Thank you, Bill, for replying to the one who tried to re victimize us again by saying to that one, "When you say lies are being told you re victimize those who have had enough victimization from those they trusted. Lastly, don't let yourself be bitter or negative. Be positive, force yourselves, and FIGHT! For your rights, and your decency. People who do this kind of thing are not always monsters, sometimes with the proper help they can overcome this, check out stopitnow. org for more information. This place may help you too.

You've got to be strong, within, and keep on talking to others about it until something is done to combat it. You won't change things by writing it here, tell the FBI! All of you.
