Writing in this summer's issue of Notre Dame Magazine Mr. Salveson shares his awakening of the 'risk-management' style that his church employs in child sex-abuse cases. When reading: "In my own case, I always wondered why the bishop I wrote to in 1980 ignored my first letter to him." brought back memories when I wrote to a Bethel Elder (as he was called then) years ago regarding his actions in not protecting me as a child. Only in my case the Bethel Elder ignored both letters I mailed him. "A revelation Slowly, eventually, I figured out the reason for the lack of progress within the Church. It really was simple. I had long believed the Roman Catholic Church considered the child sex-abuse crisis to be a moral issue. So I expected clergy to care about the victims and to do the right

thing. But the simple truth I had learned over time was this: Much of the Catholic leadership does not view this as a moral issue. They view it as a risk-management issue. The focus is on managing settlements, keeping the topic out of the media, telling the faithful everything is taken care of and, most of all, doing everything humanly possible to ensure none of these cases ever make it into a court of law. An institution focused on doing the right thing would admit wrongdoing, immediately remove abusive priests from ministry, embrace victims, reach out to their families, do everything possible to help them heal, and work to change laws that hide perpetrators and deny justice to victims. However, an institution focused on risk management never admits actual culpability; it protects predator priests, does the bare minimum for victims and works to keep outdated laws in place to protect perpetrators. Suddenly it all made sense. In my own case, I always wondered why the bishop I wrote to in 1980 ignored my first letter to him. I wondered why he refused to tell those pastors and other bishops supervising my perpetrator that he had been accused of sexual abuse. And why in all of those nine years of pestering the Diocese of Rockville Centre to dismiss the priest, I never received a written acknowledgement that the priest had in fact abused me. I wanted supportive, empathetic some might call it Christian action from the Church. I had not realized they were just managing risk. To this day I still am embarrassed by how long it took me to understand this." http://magazine.nd.edu/news/40695/Yes, Jehovah's Witness leadership can be just as ice cold as Catholic leadership.

JW SISTER INDICTED CHILD RAPE

MURFREESBORO A mother accused of raping her two children multiple times when she lived here more than 10 years ago was indicted by a grand jury this week on 38 sexually-based offenses. Indictments issued against Angela Elizabeth Montgomery, now of Portland, Ore., show police have identified two new victims in the case, and that investigators have evidence Montgomery tried to coerce two witnesses during the Murfreesboro Police Department s investigation into her alleged criminal activities. Montgomery, who is now 50, was indicted this week on 20 counts of child rape, six counts of rape and 12 counts of incest. She also faces two counts of coercing a

witness to a crime, according to court documents. She was initially charged with two counts of child rape by Murfreesboro Police Detective Wayne Lawson in late August, after her two children gave the detective detailed statements about rapes and sexual assaults they suffered at the hands of their mother when they lived in Murfreesboro more a decade ago. New charges returned by the grand jury indicate Montgomery may have committed more sexual crimes against at least two other children as recently as 2009. Three of the victims in the case have the same last name, court documents show. Lawson launched his investigation in mid-January of this year after two of Montgomery s children, now a 21-year-old man and 15-year-old girl, approached him with information on her actions. Montgomery turned herself into the Rutherford County Adult Detention Center Aug. 21, after Lawson obtained warrants for her arrest on two counts of child rape. She was freed from the jail on \$10,000 bond shortly after she was booked. Police said at that time they were suspecting more charges and more victims to come forward in the case. MPD spokesman Kyle Evans, when contacted about the possibility of even more victims on Friday, said the department doesn typically discuss ongoing criminal prosecutions once the adjudication process has begun. An attempt to reach Montgomery for comment Friday afternoon was unsuccessful. She is scheduled to appear in Rutherford County Circuit Court Dec. 17 for an arraignment.

As an exJW, I know how easy it would have been to simply accept the mandate from Brooklyn and tow the Watchtower line. I just recently found out that my sister, also an exJW, was molested by an elder in our congregation growing up. She never told me until we had a frank and open cross country phone conversation. She was only 5 at the time and she never reported it to anyone. I was shocked and then connected the dots and realized this same elder has now been disfellowshipped twice for "unknown" reasons. My heart goes out to anyone who has had to suffer through sexual molestation. For all those who have been through this ordeal, I can say that through Christ, anything can be healed. My sister is now happily married to a great guy. They have a loving and peaceful marriage built on a strong relationship with Christ, and expecting their first child. There is hope. As for me, I left the JW organization soon after I graduated from college. I grew up during a time where college was strongly discouraged. I graduated from high school and was working to make a living, eagerly awaiting the end as everyone else. One day, a fellow worker gave me a pamphlet that pinpointed all the times that the JW organization had predicted the end and it never materialized. I just put 2 and 2 together and said "if they've been wrong before, they can be wrong again" and that's when I put myself into college. After leaving the JW organization, I was so disillusioned with religion that

any remnant of "faith" was completely shattered - I can see why many people who leave the JW organization become agnostic or atheistic. Eventually, it was only through the writings of Lee Strobel and CS Lewis that I was able to start piecing back my faith. For those who are in the same situation, I can only say you can give up on religion but I hope you don t give up on Christ.

Hi to everyone

First, I wanted to say hi to everyone. I'm sorry to see new cases here but glad people are coming forward. It's also good to see the courage survivors are showing. As most know, my own daughter was a victim at the age of 9 and my posting here to warn others about the sick animals who run the WT cost me my marriage and my daughter. I am being shunned for warning others. My daughter married 2 years ago and I was not invited. I also lost my mother because she died due to what happened. PLEASE NOTE THIS: There is a verse that shows only ONE witness was necessary under the Mosaic Law. It's found at Deut.22:25 and clearly shows that if a woman was raped and no one could help her, she was innocent but the man was killed. When the elders, most of whom barely graduated high school, demand two witnesses, show them that verse. If they say the Law is no longer in force, remind them how often they quote from it when they want to establish policy but the New Testament has no rules about certain things. They are quite eager to bring out the Law when it suits them. Hypocrites to the end. I also wanted to make one more statement and I'll leave it to others to judge it. About 3 years ago, some JW man, about 20 years old I think, threatened to kill ex-JW's who accused the WT of protecting pedophiles. I don't look for trouble like this, but I won't stand for "innocent lambs" being threatened. Since his statement was on some JW forum, I posted that I live in Florida and have a concealed carry permit. I always have one gun with me and often two. I replied to his threat that if he confronted me and made that threat, I had the legal right to shoot him. I will never stand by while innocent people suffer. Not my life and not others. I find it incredible that the WT and JW's are now so desperate that some are threatening murder. If anyone threatens a survivor, I know the local police would love to hear it. There are many cops in my family and it is against the law to threaten deadly harm to others. I urge every survivor to stay strong and tell their story to every media person who will listen. Florida has strong laws against pedophiles and they often get life in prison. Most towns have newspapers with all the data on pedophiles: address, picture, age, crime, description, etc. They don't play around down here. See if a local cable show will do a story, Google authors and see which ones write about this topic in newspaper columns, Internet blogs, and Facebook causes/pages. The WT is going down and we have the chance to make it happen even sooner. You can also sue them. It costs them time and money to pay victims and the publicity angers them very much. I've warned all my neighbors and when I see them enter a development a mile down the road, I tell a few people what happened and they quickly call and warn each other. I am called names but NO ONE ever threatens me. The local KH knows me very well and has my data on a big card in their file. I'm the "East Coast Apostate" to them and I'm proud of it. Standing at a crossroads & ready to report them ...

I sat for six hours for an abuse certification to work with children; the last type of abuse was family abuse. Everyone was visibly shaken but I felt sick, like someone had just hit me in the gut taking my breath away. That day began a long nightmare that I still fight. I told my mom her father had been hurting & threatening me since I was 5 & she put her hand on my knee saying "I know". I realized this secret was bigger than anything I could imagine- generational. They quickly instructed my husband to keep me in the house or they could find a hospital to put me in because this was not to get out period!! The family is strong, the years of cover up also by the congregation was bigger than me. The elders sat telling us that he was a fine elder & pioneer so for them to believe this I would need at least two other witnesses. They knew an abuser was far too clever to be seen by anyone let alone two others. I went to Bethel, two committees, family & other congregations and no one would help. I was also raped by a ministerial servant who was known to have prior issues, a very close father figure. No one was going to listen!! I'm stronger now and their yrs of hurting me are done. The stories are too long and painful to put here. But I would like to use them and what I have lived through to help others, but first I need help with knowing how to report this. I know there are statute of limitation issues. I just found out he has hurt three more girls, that he lies that I'm making this into something it's not. I am right, sane and strong enough. My parents had a chance to do the right thing instead they moved him to yet another congregation. They say I'm being hateful, disrespectful for not letting this go, for not letting him live out his last yrs happy and peaceful, that he's too old to hurt anyone anymore. The same things they've accused me of since I came forward, saying he was too old to hurt anyone just leave him and them all be. But he hurt three more girls I've come to find out after I went to Bethel . I'm the only one of them who feels it's important to come forward, they refused to back me & report him even back then. They are still saying it's Jehovah's place to handle in his time, that Jehovah says we are to respect and care for our parents and not to question their actions or those of our elders who have been appointed by God. That's not good enough for me, if I'm going to change the pattern of silence I have to try again. Last time the brothers, family, approved doctors all threatened (or they'd call it strongly encouraged) me to not report to police, that it was a matter of God to handle in his time and by reporting I would not be trusting our loving creator. That shit isn't good for me anymore!! It's harmful, more people end up getting hurt!! I think I'm strong enough now, I have to break the silence by screaming louder. If anyone has recently gone to report someone, or

has advice. I live in Ohio, I'm sure there are limits to the number of years, but does that mean I can't report at all.? He has hurt 9 kids. The ministerial servant who raped me was much the same. He had prior problems, then raped me, family refused to press charges outside the kingdom hall and he went on to hurt two more girls that I know of. I could used some advice,my family are generational position holding members who enjoy the appearance, who will not go quietly for fear of how they will look. This concept can have dire consequences, especially when dealing with two other elders who are ignorant to the law, have a prejudice, are in a hurry, or, are just stupid! I was on a committee recently where Yielding went terribly wrong. A 14 year old girl was sexually attacked by a 16 year old boy with a troubled history. The girl was doing everything right when it comes to telling the truth. She filed a Sheriff's report of aggravated sexual battery, and needs psychological assistance. Due to prejudice from one elder that benefits financially from this boy's parents, he had the strongest voice in the meetings. The other brothers had to fall in line or have their qualifications questioned. This creates a homogenizing effect. There is no longer an opened minded conversation to evaluate facts and apply [Watchtower policy] in an elders meeting. How sad! The results in this case: the girl, (the victim) was disfellowshipped and the boy was privately reproved. It was appealed. However, as is the case in almost all cases, it was upheld. I wrote this him to him August 27: Dear Raymond, something terrible has happen to our family, our daughter Mette's 21 year old daughter Jessica was killed in a car accident yesterday, Wednesday. Mette asked me today if you could help us with some guidance for the funeral service, just a little talk. You are the only one who can help us now in this sad situation. We just sit and cry. Please help us. Kind regards Ole Helle-Broe, Australia. The same day, August 27, he send us this comforting letter: Dear Ole and family, We were very sorry to hear of the death of your granddaughter, Jessica. I am sure it will take some time for you to adjust to the loss, and even more so on the part of her mother. God s Word recognizes the uncertainty of life and the unpredictable circumstances that can occur, as Ecclesiastes 9:11 says time and chance (unforeseen occurrence) happen to all. God s Son was himself moved to tears on seeing the grieving of Lazarus sisters at the time of Lazarus death. (John 11:33-

35) Even as the greatest appreciation of water comes with being very thirsty, and of food when being very hungry, or of sleep when being extremely tired, so too one can appreciate the crucial value and beauty of the resurrection hope, and the strength it gives, most particularly when experiencing the loss of a loved one, or when facing death oneself. The Scriptural knowledge shared by you and your family that death is comparable to sleep and that those sleeping in death can be awakened from that sleep by Christ s call awakening them to return to life (John 5:25, 28, 29) aids tremendously to give relief to sorrow, so that as Christians we may not grieve as do others who have no hope. (1 Thessalonians 4:13, 14) You have the hope of seeing Jessica again and should feel even more motivated to faithfulness in your service to God and his loving Son who will make that possible. I completed 88 years of life in May and Cynthia reaches 76 in August, so we both recognize that the time remaining for us is not great. One thinks of the words of the psalmist. Our years come to an end like a sigh. (Psalm 90:9, 10) While our outer nature is wasting away, our inner nature is being renewed day by day, as we look not at what can be seen but at what cannot be seen, not at the temporary, but at the eternal, having entrusted ourselves to a faithful Creator. (2 Corinthians 4:16-18; 1 Peter 4:19) As regards a funeral service this is entirely a matter for personal choice. For myself, following my death I would personally prefer not to have some formal service held in a funeral parlor but would prefer that those of my friends who are able and would care to, would come to our home to meet with my wife and join together in comforting her, recalling whatever pleasant association they had had with me, and any experiences of worth and value that resulted from this. But as I say, that is only my personal preference and is not presented as something for others to be guided by. Mette s wishes should be given priority and if she feels a regular funeral service is best then that is what you should do. I will never stop exposing these perverts. I was concerned about a few personal things but have worked them out. I also have heart disease and sometimes have good and bad times. I've been in the computer field since the 1980's and have read almost every book the WT ever printed. So I can do the most good for victims using my knowledge of the Internet and doing research. I also mention that I have a BA in Psychology from time to time so new people will know I do my best to understand the dynamics of child abuse. The WT doesn't care about people. Print out and show the police the "murder letter" where the GB tells the elders not to report a known murderer who was associated with the congregation. And if possible, despite the economy, maybe send a few dollars to Silent Lambs. Every little bit helps. Before you visit both the police and a lawyer, try to have all the details in order and written down so that they can study your case quickly and can let you know what can be done. I am not surprised that they ignored your deadline and ultimatum. The WT thinks it owns the Earth so they will never allow a "puny non-anointed human" and especially a woman, to tell them what to do. There are only TWO things the WT understands in cases like this. FORCE and MONEY. When they are sued, you'll get their attention. And if any are put in prison, they will suffer. Ireland- Finally getting out of the dark ages!

The recent state commissioned investigation into child abuse covering the period of the 1960 s to 1980 s has resulted in a long awaited apology from both the Catholic Church and the Irish State itself. Many senior figures within the church have had to resign, while others are considering their position based on their inaction when cases

were reported to them or where they deliberately covered up cases to protect the Church. It s interesting that the Gardai (police force) came under criticism for being reluctant to take action, and that the investigation also stated that elements of the state colluded in the covering up of abuse. Investigators had to sift through over 60,000 previously secret church files including some 5500 withheld secret files by the Cardinal in his private vault. This investigation found that 46 priests abused over 300 children in the Dublin area alone . and that "the reputation of the Church had been put above the welfare of the children Many Irish people have described this as the ultimate abuse of trust and that not enough has been done and have called on the Pope to come to Ireland to say he s sorry for the damage done. Do any of these comments sound familiar? Are Jehovah s Witnesses Ministers separate from this sort of conduct? Do they apologize where there has been wrong doing in the area of child abuse? Well, from my own personal experience the answer is no. I reported the sexual abuse of my daughter to the Congregation Elders in 1992 thinking that it would be dealt with and resolved in a Christian way. Instead the next few years would be spent with the majority of Elders intent on not only trying to cover up the case and pervert justice, but also trying to discredit me in every way possible so that they wouldn t look bad. The sole issue that was of concern to the congregation was that of the Elders own personal reputation and position and second to that was the name of the organization. Was the reputation of the Elders and Congregation put above the welfare of the flock? Well to answer that for yourself, consider that during those years my family had to contend with the attempted suicide of our abused daughter and all the problems that come with dealing with child sexual abuse with no support from the congregation. Add to this the fact that the Elders had a report of physical abuse of the abusers wife and the sexual abuse of the abusers own daughter during those years! Did the congregation move to have the case investigated by the Gardai? No, quite the opposite, in 1995 the Gardai had to threaten the Congregation overseer with prosecution just to make a Garda statement after I had reported the case to the authorities for investigation. Prior to this I was told NOT to release the name of the abuser to the Health Authorities or to inform the book study conductor in the abusers new congregation of the accusation against him. Interestingly, after the investigation got under way the Circuit Overseer s advise was that I didn t have to turn up in court if the prosecution against the abuser went ahead and that the case would fold! This suggests that they knew the case was true and would go to trial. To cut a long story short the abuser resigned from the new congregation, then admitted the sexual abuse of my daughter in a meeting between myself, his own wife and an Elder from his new congregation. My daughter & myself agreed to drop the charges and accept a meeting with the authorities and abuser to settled the case out of court as had originally been done in another Irish congregation according to the Circuit Overseer. This never happened and the Elder involved in the meeting has refused to report the abusers admittance to this day to the Gardai, even though the abuser had resigned from the congregation! He fled the area and has not being charged. This case opened a flood of reports of child abuse cases that had been swept under the carpet in nearby congregations, although nothing was done about them in the past, not surprising given the culture of Irish society, it is my hope that the publishing of the Catholic Church investigation will give new hope and confidence for victims to come forward with their stories and to be acted on. The Cork Congregation in question has since changed its name, due in some respect I believe to cover it s past reputation, but the Elders that carried out the ultimate abuse of trust are still around, pretending there s nothing wrong, pretending that they have children s best interest at heart, pretending they are shepherd s of Christ s flock.
